

INVITATION TO BID

NOTICE is hereby given that the Jefferson County Highway Department will receive sealed Bids until the 16th day of January, 2020 at 10:00 a.m. local time at the office of the Jefferson County Engineer, Jefferson County Highway Department, 750 Old Fairfield Road, Mount Vernon, IL, 62864 at which time the sealed proposals will be opened and read publicly in the office of the Jefferson County Engineer for the following project: CH 36 (General Tire Lane) Work description: The project is located on CH 36 (General Tire Lane) from Woodland Drive to IL Route 142 in Mount Vernon, Illinois. The length of the improvement is 4394 feet or 0.8322 miles. Proposed improvement includes the removal of the existing pavement, construction of PCC Pavement (Jointed) with combination concrete curb and gutter, installation of storm sewer and culverts, grading of ditches, installation of recessed pavement markings, erosion control, and restoration of disturbed areas with seeding.

The Contract Documents may be inspected and purchased at the Jefferson County Highway Department, 750 Old Fairfield Road, Mount Vernon, IL 62864. Payment for printed Contract Documents is non-refundable and shall be payable to Jefferson County Highway Department in the form of cash, certified check, or money order. The non-refundable cost for plans and specifications is \$25.00. Electronic version of the bid document will also be available. Please email sacree@hlreng.com to request the bid documents. Please include company, contact, address, and phone number in the body of the email request. Attach a copy of a current IDOT Prequalification.

Addenda will be issued only to plan holders that purchase or request the information electronically. Bidders will be required to provide Bid security equal to five (5) percent of the Bid in the form of a Bid Bond written by a company properly licensed in Illinois, a certified check or a cashier's check. The successful Bidder also must comply with the Illinois Department of Labor Prevailing Wages for Jefferson County. Jefferson County Highway Department, in accordance with the Laws of the State of Illinois, hereby notifies all Bidders that the County reserves the right to reject any and all Bids, to waive minor informalities or technicalities, to advertise for new bids, or to request confirmation or clarification from any bidder regarding information contained in a bid. The Jefferson County Highway Department will affirmatively ensure that the contract entered into pursuant to this advertisement will be awarded to a responsible and responsive Bidder without discrimination on the grounds of race, color or national origin, but the Owner reserves the right to reject any or all Bids received and to waive formalities. Your Bid will be required to be submitted under a condition of irrevocability for a period of sixty (60) days after submission. Bids shall be received in a sealed envelope addressed to the Jefferson County Highway Department, 750 Old Fairfield Road, Mount Vernon, IL 62864, which is marked in the lower left-hand corner EXACTLY as follows:
