

Ordinance No. 2018-04

AN ORDINANCE BY THE JEFFERSON COUNTY BOARD ADOPTING THE SALARY SCHEDULE FOR JEFFERSON COUNTY CLERK & RECORDER, TREASURER, SHERIFF AND CIRCUIT CLERK OF THE COURT

WHEREAS, County Boards have the authority to set salaries and/or per diem of County Elected Officials within the guidelines set forth in the Illinois Revised Statutes, and

WHEREAS, salaries and/or per diem for most elected officials must be set at least 180 days prior to the date the elected official assumes the duties of the office; now,

BE IT ORDAINED BY THE COUNTY BOARD OF JEFFERSON COUNTY, ILLINOIS THAT THE SALARY SCHEDULE BE SET FOR THE FOLLOWING OFFICIALS:

COUNTY CLERK & RECORDER

Shall be set forth below:

Salary effective 12-1-2018 shall be \$ 53,500.00 per year

Salary effective 12-1-2019 shall be \$ 55,500.00 per year

Salary effective 12-1-2020 shall be \$ 56,500.00 per year

Salary effective 12-1-2021 shall be \$ 58,500.00 per year

COUNTY TREASURER

Shall be set forth below:

Salary effective 12-1-2018 shall be \$ 53,500.00 per year

Salary effective 12-1-2019 shall be \$ 55,500.00 per year

Salary effective 12-1-2020 shall be \$ 56,500.00 per year

Salary effective 12-1-2021 shall be \$ 58,500.00 per year

SHERIFF

Shall be set forth below:

Salary effective 12-1-2018 shall be \$ 68,000.00 per year

Salary effective 12-1-2019 shall be \$ 69,000.00 per year

Salary effective 12-1-2020 shall be \$ 70,000.00 per year

Salary effective 12-1-2021 shall be \$ 71,000.00 per year

CIRCUIT CLERK OF THE COURT

Shall be set forth below:

Salary effective 12-1-2018 shall be \$ 54,500.00 per year

Salary effective 12-1-2019 shall be \$ 55,500.00 per year

Salary effective 12-1-2020 shall be \$ 56,500.00 per year

Salary effective 12-1-2021 shall be \$ 58,500.00 per year

Also, the County shall pay \$500 per month toward County Insurance package official chooses, but will not pay a stipend if official chooses not to carry County insurance.

ORDINANCE NO. 2016- 06-02

AN ORDINANCE BY THE JEFFERSON COUNTY BOARD ADOPTING THE SALARY SCHEDULE FOR JEFFERSON COUNTY CIRCUIT CLERK, STATE'S ATTORNEY AND CORONER

WHEREAS, County Boards have the authority to set salaries and/or per diem of County Election Officials within the guidelines set forth in the Illinois Revised Statutes; and

WHEREAS, salaries and/or per diem for such election officials must be set before the date the elected official assumes the duties of the office; now,

BE IT ORDAINED BY THE COUNTY BOARD OF JEFFERSON COUNTY, ILLINOIS THAT THE SALARY SCHEDULE BE SET FOR THE FOLLOWING OFFICIALS:

CIRCUIT CLERK

Shall be set forth below:

- Salary effective 12-1-16 shall be \$54,049.68 (no increase)
- Salary effective 12-1-17 shall be \$54,049.68 (no increase)
- Salary effective 12-1-18 shall be \$54,590.18 (1% increase)
- Salary effective 12-1-19 shall be \$55,681.98 (2% increase)

STATE'S ATTORNEY

Shall be set according to state law and not by County Board action.


CORONER

Shall be set forth below:


- Salary effective 12-1-16 shall be \$35,472.88 (no increase)
- Salary effective 12-1-17 shall be \$35,472.88 (no increase)
- Salary effective 12-1-18 shall be \$35,827.61 (1% increase)
- Salary effective 12-1-19 shall be \$36,544.16 (2% increase)

Also, the County will pay \$500 toward the county health insurance package, but will not pay stipend if they choose not to carry insurance.
