

2021 ASSESSMENTS FOR JEFFERSON COUNTY, ILLINOIS

“Notice to Taxpayer”

Assessment complaints may be filed with the Board of Review from this date to 30 days after publication of the assessment list in accordance with the Illinois Revised Statutes Revenue Act. Assessment Complaints will be taken by this office through Thursday, March 17, 2022.

Notice is hereby given, pursuant to Property Tax Code (35 ILCS 200) under Section 12-10, for the publication of the 2021 changes in assessed valuations for real property and equalized under Section 9-210 and 10-200. As required by Section 9-205 and 9-210 the following 2021 equalization factors have been applied by township/assessment districts to all property except farmland and coal assessed under Section 10-110 through 10-140 and 10-170 through 10-200 of the Property Tax Code to bring the assessments to the statutorily required three-year median level of 33 1/3%. By law (35 ILCS 200/9-145) assessments of property, other than farmland and coal are required to be assessed at 33 1/3% of fair cash (market) value. Assessment changes prior to equalization are published.

Township Multiplier for Bald Hill, Blissville, Casner, Dodds, Elk Prairie, Farrington, Field, Grand Prairie, McClellan, Moores Prairie, Mount Vernon, Pendleton, Rome, Shiloh, Spring Garden, and Webber is 1.0700

By law (35 ILCS 200/9-145) assessments of property, other than farmland and coal are required to be assessed at 33 1/3% of fair cash (market) value.

Your property is to be assessed at the statutory level of assessments of 33.33%. You may check the accuracy of your assessment by dividing your assessment by the median level of assessment. The resulting value should equal the estimated fair cash (market) value of your property. If you believe this value is out of line with the actual value of your property you may have the right to appeal your assessment to the Board of Review. **FILING DEADLINE IS MARCH 17, 2022.**

A detailed description and assessment records of all parcels within your county are available in the assessor's office during regular business hours. If you believe the full market value of your property is incorrect, or its assessed value is not uniform with other comparable properties in your area, or an error has been made you should first talk to your township or multi-township assessor. Before filing an assessment appeal, an attempt should be made to review the details of your property with the local assessor. If you are not satisfied with the informal review, you may appeal your assessment to the Board of Review. Appeals must be filed by the deadline. If you file late, your appeal will not be heard.

Pursuant to 35 ILCS 200/10-115, the farmland assessments for the 2021 assessment year will increase by 10% of the preceding years median cropped soil productivity index as certified by the Illinois Department of Revenue with data provided by the Farmland Assessment Technical Advisory Board resulting in a \$35.21 per acre increase for each soil productivity index.

The amount of your tax bill is determined by taking the equalized assessed value (after board review and state equalization) of your property and applying the aggregate tax rates from the levies of all local taxing districts and units of local governments in which your property is located. Your property tax bill is calculated as follows:

Final Equalized Assessed Value – Exemptions = Taxable Assessment
Taxable Assessment x Current Tax Rate = Total Tax Bill

You may qualify for exemptions on your property which will reduce your property's equalized assessed value. Exemptions are available for general homestead, senior homestead, senior citizens assessment freeze, homestead improvement, disabled persons, disabled veterans, and returning veterans.
