\*Although the express language of Section 7-10(i)m which applies in this instance, requires not less than 10% nor more than 16% (or 50 more than the minimum, whichever is greater) of the primary electors of the candidate's party in the ward, the U S Court of Appeals for the Seventh Circuit held in *Giersten v Board of Election Commissioners for City of Chicago*, 791 F 2d 472 (7<sup>th</sup> Cir , 1986), that a signature requirement in excess of 5% is unconstitutional and thus unenforceable. Thus, 5% of the primary electors of the candidate's party in the ward is the minimum number of signatures required for ward committeeperson petitions.
